- 5. Some roads received cold patch
- 6. Dirt Roads have had liquid magnesium put on them
- 7. The crusher was supposed to move in today at the gravel bank and the owner contacted Ron and stated he was sorry that he was behind and stated due to the delay they would crush extra at no charge.
- 8. Ron states that he feels he does not need to go through the bid process to purchase a new 10 wheeler after checking with other road supervisors.

- 11. This year Ron has hired Dylan Wood and Carolyn Butler as summer help, they will be starting in 2 Weeks.

- 1. Received in the mail Coalition of Wathershed Town Ballot and noticed it has wrong names on it. Bill will contact then and request it get fixed and new Ballot be sent out.

- 3. Bill again has tried to get Sam Rowe to set up a date for a meeting to discuss the transfer station and again has heard nothing back.
