- 1. A thank you letter has been composed and presented for the board to review for the Kounty Critters 4 –H Club thanking them for cleaning the cemetery on Windfall road.
- 2. The Delaware County Board of Election is going ahead with consolidating the 2 Tompkins EDs into one, to be located at the Tompkins Town Hall in Trout Creek. This will mean the elimination of the Kelsey Community House as a poll site. They will be notifying the NYS BOE shortly of this change, and you can rest assured that Robin and Paula will send cards with the new information out to your voters prior to the Presidential Primary on April 19, 2016.
- 3. Still have not received a budget from The Hancock Fire District.
- 4. Bill provided Ron with a list of items that need to be in the First Aid Kit to be OSHA compliant. Ron can provide this list to the medical supplier that is excessively stocking the first aid kit and keep the costs down.
- 5. Received a email from Patrick Keem, Orchard Park Supervisor asking each Town Board member to sign a letter to be sent to Governor Cuomo requesting that the Tax Cap Legislation be revisited and amended in such was as to alleviate unforeseen negative consequences.
