Guest Speakers: Chris Yacobucci & Mike Jonker came to advise the board on issues with sewer district. Chris and Mike explained that there were settlement issues with property owners and that it has been reviewed and that the settlement issues will be fixed in the spring by Reynolds Construction. Chris and Mike reviewed the with the board issues with the current pump outs and how we will have to send specific letters to those home owners that are abusing the system they also stated that we should contact Kevin Young's and ask him if our sewer use law will allow us to charge home owners for abuse of the system if it ever comes to issues with pump outs of those systems. Chris and Mike discussed the sewer district budget process and how things are done with that and discussed how future budgets can be done in a timely manner. A discussion took place on who was responsible for the meter that will need to be placed in the store. Prior owners refused to let a meter be placed because at that time it was not a working business. Chris stated that it is the property owner's responsibility and it would be beneficial to have them install the meter. Bill explained he will contact CWC about funding of the meter and we will contact Kevin Young to see if it can be funded through the budget.

Lynn VanValkenburg reported to the board how prior fund raisers have gone. Lynne Questioned the board if they would re bid the furnace, the board will put another bid out in the paper. She also stated they would not be using the school house during the winter season so it will need to be winterized and pipes drained. Bill Layton and Mike Preston will winterize the school house. Lynne stated that she heard that the school house was declared a "Historical building" but she has not had any official notice.

Highway Superintendent

- 1. Have been working on Chase brook, Rock rift and started Readburn after that road is complete will start working on Chamberlin Brook.
- 2. Finished Boom mowing of Roods Creek.
- 3. Began getting trucks ready for winter
- 4. Some trucks have been sent to Bennett's in PA For alignment
- 5. Sam's truck needed wheel bearings changed
- 6. Kyle's Trucks has been serviced and had a tool box put on
- 7. The Massey Furgerson tractor has been put in creamery for storage
- 8. The new mower is stored in pole barn
- 9. The 2013 International is had received warranty work at Ben Funk

- 12. There has been some bank erosion on Dufton Hollow it was fixed and bank stabilized.
- 13. Barbour Brook was washed out above Bonker residence and that too had the bank stabilized
- 14. Pipes were changed on South Dry Brook and Franskevicz Road
- 15. Sam VanValkenberg has worked 20 years and qualifies for longevity pay.
- 16. The form for Hanks warehouse needs to be changed for boot purchased and have Johns name taken off and Josh's put on.
- 17. Ron questioned Brian if he had called around and got quotes for hauling, Ron stated he asked Reynolds construction and they said it would be \$90 an hour.
- 18. Ron stated that in 1997 there were 7 highway employees and now they only have 5.
- 19. Ron looked into Sanders for 1 Ton with the cost of \$3854 and found that Air Flow makes them and would like to have an extra just to have on hand.
- 20. The NYS DOT has submitted to the Town proposed listing of roads from an Arial measurement that preformed. Ron stated that according to the sheet some of the Town roads were shorter and or indicated to be a private road of about 1.56 miles and could cause us to receive less CHIPS money in the future.

We need to decide if we agree with changes or not. If we do not agree we need to do a Resolution. On Motion by Albanese, Seconded by Layton to provide a resolution stating that the Town indicates that the roads mentioned are actually unrestricted and we accept full legal, liability, and maintenance responsibility so that NYS DOT can restore the roads to the local highway inventory.
