## **Highway Superintendent**

- 1. The stone and oiling on Little Dryden, Windfall run, Aloyo, Mormon Hollow, where Finch/Dryden intersection meet is complete.
- 2. Some shoulder work has been done on Gray road and part of Dryden.
- 3. Hauled some of the Grindings from NYS DOT to portion of Roods Creek and also put some of our gravel on top.
- 4. Patched portions of Tower Mountain Rd. This road needs a lot more work so Ron has asked for quotes for repair from Suit Kote and Cobleskill stone. This is going to be a heavy estimate due to the amount of work that is going to need to be done.
- 5. The 2006 International is at Milton cat due to some cylinders are not firing, they think it is the ECM Board, which has been ordered and will be replaced.
- 6. The 2016 is still at Ben Funk and has been for over a month. They have to get approval from International to proceed repairs because it is under warrantee. At one time they thought they had its problems figured out but it wasn't that so they again had to contact International for approval. Ron stated he has contacted the main headquarters of Ben Funk and was hoping to push to get the truck fixed.
