Ron stated that he wasn't sure the program he spoke about was an actual Lease. Ron will have some companies come to the board meetings and explain the program.

- 7. Ron stated he figures that with all the equipment we use and time we have only received a .10 cent increase sense 2011 for plowing County Roads.
