Guest Speaker:

Lynne VanValkenburg – questioned the board on where we were at with the new furnace for the school house. Bill said contract has been signed and a portion of the money owed had been sent to harts, and has not heard any further from them on when they will be doing the install. Tammy Wagner stated she talked to them and they should be here this week.

Assessor – Wendy spoke with Bill that some residents may be upset for not getting the star next year. Wendy explained she tried to get them to turn in paperwork on time and the correct paperwork before the cut off date, but she didn't hear back from some of them so there was nothing she could do.

Highway Superintendent

- 1. Friday the NYS Dept of Labor inspectors showed up. They noted some violations and stated the list of violations will be sent within the next couple of weeks.
- 2. This far we have been out 69 times plowing and sanding
- 3. February 25th we had a rain event, we had no serious damage just some plugged pipes. While out checking roads and pipes Ron noticed that the 3ft pipe on Bridge Street is rotting out. We also had some high winds and some tree limbs came down.
- 4. The grader is at Milton cat getting brakes and fuel lines repaired, it may needs some additional work.
- 5. Ron questioned the salesman about the value of the Ford and Massey tractors, they estimate the ford is worth \$3,500 \$4,000 and the Massey with mower is worth \$5500 \$600. They will be put out for auction.
- 6. The Delaware Co DPW is going to rent an Athey machine for shoulder work, while they have it we can use it but will need to pay them for its use. Ron would like to use it on Tower Mt and other roads he wants to top.
- 7. On February 28th 3 of the guys were doing some ditch work, there was some miscommunication and a pickup truck came through the work zone and at that time the truck was ran into with the backhoe causing damage to the truck. Ron stated he covered all bases and it has been turned into insurance, Last report Ron received is it will be covered by our insurance.
- 8. Today while preparing for the snow storm the front drive shaft on the John Deere loader broke.
- 9. We are down one truck due to a sensor issue.

- 1. Peter Innis from Environmental Conservation called and stated that the office of general services has cleared the Rock Rift Fire Tower to move on to initial steps. He stated he is not exactly sure what that means but it's a major hurdle that has been overcome.
- 2. Bill found that DCEC received a grant to get faster internet.
- 3. We received the new service contract to have the Town Hall Generator serviced, it will be \$225 a year
- 4. Bill asked if anyone has looked into the Fed Surplus and Municipal grants.
- 5. Bill stated he questioned Wayne Reynolds about the Pelican machine and he found no one he has ever spoken to about it has seen an advantage of its use. Wayne also stated that CWC gives out grants for them if we want to look into it further.
