#### **Guest Speaker:**

Rick Roberts from Finger Lakes Trail System came to discuss the release from the state of the Fire Tower and the next steps the Town could take. Rick explained that the Tower would now need an inspection to see what repairs need to be done. Rick explained that it is advisable to have a fence put around the Tower. There is a non-profit organization that will help with writing and securing grants for repairs of the fire tower. Rick also stated there is a crew called the Alley Cat Crew that pick 5 projects (fire tower) a year and help with repairs, they bring their own Engineer and foreman's that will assess the towers and explain all that is needed to be done. Also, the Finger lakes trail system have funds set aside for these types of things.

## **Highway Superintendent**

- 1. The 1995 Chevrolet was inspected last month at Hanley's and for it to pass inspection it will need to be plate welded to pass inspection. Ron questioned the board if it was worth it.
- 2. Ron would like to have a law proposed on parking in roadways. It has become an issue with some roads and is becoming practically impassable in some locations at times. Ron will look into getting laws from other towns and see what he can come up with.
- 3. The grader has a broken axel, parts have been ordered.
- 4. We have been helping other towns with hauling (Hamden, Walton)
- 5. Gravel has been hauled, moving and trimming continues to be done.
- 6. The roads that will be paved are ready and we are just waiting on good weather.
- 7. Ron again discussed with the board the purchase of the Athey Machine. After much discussion and on Motion by LaTourette, Seconded by Albanese to purchase the machine for \$22,000 and to see if the shared services with the state will help with the transportation. Vote: All Ayes Motion Carried.

They are in the process of running lines toward our area to provide Phone, Internet and television to provide these services. They will be coming to a board meeting soon to discuss this further.
- 3. Albanese has mailed in a second grant request for a Loader.
- 4. Received a call from the County stating we can hire one more summer help.
