Jason Miller, Jason Woodyshek and Ken Prestige presented to the board the new Cable Television Franchise that would be coming through portions of the Town of Tompkins that would provide Cable and Phone to some residents. Mr. Miller explained an overview of what the project is and provided a Franchise Agreement for the board to review. They are also looking for a good location on a Town of Tompkins property to set up a small building (substation). DTC will keep the board up to date as the project progresses.

Highway Superintendent

- 1. Ron stated the windows in the breakroom and the office are leaking again, and after sealing them many times he feels they may just need to be replaced. Albanese stated he will personally come down and try to fix them by sealing a different way too see if that works.

- 10. During the NYS Labor department inspection Ron was told the Town needed a Lock out Tag out Policy. He received a sample policy and Michelle had wrote up one for the Town which was presented to the board. - 1. Layton presented the draft Town of Tompkins Parking Law to the Board. On Motion by Albanese, Seconded by LaTourette to set up a public hearing for Septembers Meeting for the Town of Tompkins Parking Law. Vote: All Ayes Motion Carried
- 2. Layton has noticed that some of the Town Cemeteries are in need of stone repairs, he asked the County guy on what an approximate cost would be to have them repair the stones and was told about \$1,600. Layton stated that the cost was rather high and wondered if there would possible be a boy scout that would do something like this to get their badges. Board will ask around.
- 3. Seeing how we are proceeding with the fire tower and looking into getting grants through Fire Tower Lookout organization for repairs we should join their membership at a cost of \$20 a year. On motion by Layton, seconded by LaTourette it was passed to join the Fire Tower Lookout membership. Vote: All Ayes Motion Carried.
