Assessor – Wendy reported that the state has finished the data collection for the Town of Tompkins.

Highway Superintendent

- 1. While working roads they had used 156 Loads of gravel
- 2. Changed pipes on Chamberlin brook and Bridge St.
- 3. Helped Deposit for 2 days
- 4. Hauled some gravel from Afton
- 5. Have been working on trucks and equipment
- 6. They have been crushing gravel at the Afton gravel bank but it looks as if something may have happened with the equipment because they only crushed 8700 8900 ton.
- 7. Have done some ditch work and mowing
- 8. All cold patching is done
- 9. There is a bridge on South Dry brook that is actually on private property that goes to a house but for some reason long ago it became the Towns. The owners of the property said it needs repair, Ron went and looked at it and it is in need of repair. Ron questioned the Board to see if anyone knew how this bridge became Town responsibility.
- 10. The highway garage generator broke down during the last power outage. Ron has called Reeds Generator service and they will be coming to look at it.
- 11. Ron questioned the board if he could get a credit card to purchase miscellaneous items. Board was unsure how to do this or how it could be done and would have to look into it.

Dog Control Officer – None.

Supervisor –

- 1. We have turned in to FEMA \$24,984.71 for Storm Stella. They may or may not pay that back to us.
- 2. Layton questioned Ron if he had everything all set for the Lock out Tag out policy. Ron stated everything was set with it.
- 3. Layton questioned if we should be putting out to bid the road repairs. Layton stated he will look into that further to see if it's something the Town should be doing.
- 4. Fire Tower At this point we were told we will need a right of way to the Tower. We would need it for all the properties that would be used to get to Tower. Layton stated he had contacted some of the properties owners and is waiting to hear back from them.
